3. PLANNING APPLICATIONS TO CONSIDER

LBC/23591/H, P/00066/19 Brook Hill House, Brook. Listed Building Consent for variation of condition 2 on P/00238/18 to allow alterations to approved layout. The application referred to internal works. Brighstone Parish Council has **NO OBJECTIONS.**

TCP/23324/A, P/00070/19 Wellgrounds, Moor Lane, Brighstone. Outline for 5 residential units

with parking (revised site address) (readvertised application) Many concerns were raised: Connection to the main sewer appears to involve digging up a Public footpath parts of which are privately owned by adjacent houses. The distance of the sewer pipe from buildings contravenes building regulations. Drainage issues of the site. There are already flooding issues from surface water run off identified by residents

in Moor Lane

The Ecological Report is out of date and does not reflect a true report of existing flower and wildlife habitat. Damage to trees especially an oak tree which would suffer severe root damage and which could have a Tree Preservation Order.

Development overlooking existing properties.

Brighstone Parish Council **STRONGLY OBJECT** to the application for Outline Planning which does not offer or give sufficient detail required regarding types of property to be built, drainage routes, sewer workings and landscaping.

TCP/33721, P/01323/18 Woodlands, Brook. Demolition of garage, proposed single storey side extension A concern was raised regarding a roof light which could affect the dark skies. Brighstone Parish Council has NO OBJECTIONS.
