3. PLANNING APPLICATIONS TO CONSIDER

AGN/33766, P/00338/19 Land at Coombe Farm, off Lynch Lane, Brighstone. Agricultural Prior Notification for proposed agricultural barn.

This was a Notification only and therefore nothing to discuss.

19/00011/HOU Garden Cottage, Brighstone Road, Hulverstone. Demolition of side extension; alterations; proposed single storey side extensions.

The Parish Council could see no reason why this application should be refused and **positively recommend** it. The proposed new extensions enhance and compliment the older cottage building allowing it to stand out.

4. TO DISCUSS THE TENNIS CLUBS REQUEST TO EXTEND OR REPLACE THIR CLUB HOUSE

The concerns of drainage, water connection and parking were discussed at length. The possibility of floodlighting the courts for evening play would be against the dark skies policy. Using the Pavilion could be a possible alternative to extending the Club House. Since land the proposed extension would be on was leased by the Recreation Ground Committee it was recommended the Tennis Club approach the Recreation Ground Committee to discuss possible options with them. The Clerk would write to the Tennis Club recommending this.

A new Precedent was proposed:

Brighstone Parish Council only want to have one lease holder which is currently the Recreation Ground Committee. The Parish Council do not wish to have multiple leaseholders.
