**20/00789/HOU Willises, Upper Lane, Brighstone.** Proposed single storey side extension to form conservatory.

They were aware of the Dark Skies Policy regarding the lantern roof. Councillors had NO OBJECTIONS to the application but requested a form of light attenuation to the roof.
