### 5. TO DISCUSS THE WAY FORWARD WITH THE CHARITABLE STATUS ON THE RECREATION GROUND.

Councillors agreed at a previous meeting to write to the Charity Commission regarding the Trustee status and the current lease to Brighstone Tennis Club. The solicitor had been asked to do this but had not acted as the Parish Council had instructed. The Clerk would now write to the Charity Commission explaining there is no longer a Recreation Ground Committee, only one Trustee acting as a holding Trustee to maintain the Charitable Status, if the Lease between the Brighstone Parish Council and the Recreation Ground Committee can be shortened by 6 years causing its early termination and if we are able to discontinue the Charitable Status. A draft copy of the letter would be sent to all Councillors for their approval before sending to the Charity Commission.

Due to the current Parish Council being outgoing the incoming Parish Council will have the issue explained to enable an informed decision to be made.
